WHILE IN SHELTER, RESIDENTS HAD ACCESS TO CASE MANAGEMENT, LEGAL ADVOCACY, MENTAL HEALTH SERVICES, MEDICAL CARE AND SELF-SUFFICIENCY PROGRAMMING. 11,664 CALLS WERE RECEIVED THROUGH OUR 24 HOUR CRISIS CALL LINE AND WE PROVIDED 13,701 REFERRALS TO OTHER AGENCIES FOR ASSISTANCE.
